MODERATOR'S REPORT FOR 2025

2025 has been an inspiring year for our congregation and the community as we demonstrate our commitment to fulfilling our mission statement of "Called by Christ to create Shalom and Justice for all". Our church is thriving as we welcome a constant stream of visitors leading to more members. We see it with the variety of worship services that are offered each month and the fact that Peace Dale Congregational Church has become a solid hub for the community. Our Dinner Table, Bistro and Tabitha's closet serve an ever expanding need to feed the hungry and cloth those in need. And it is being accomplished with support not only from our members but from many others from the community who value the work we are doing and want to become a part of it. The Pumpkin sale to support Welcome House involves many members from the community and provides great visibility for us as a congregation. The Green Team also has a membership beyond our church membership. There is no doubt that we are an apron wearing congregation.

This was a sabbatical year for Fred. Our Board of Deacons did an excellent job of filling the pulpit each week from mid-June through August when we welcomed Fred back after a time of study and refreshment. This is a testament to the strong lay leadership we have within this congregation. The ever-present support of our Administrative Assistant, Mary Lou McMillian to "keep things running" in Fred's absence was also invaluable. We work together to make things happen!

We experienced a transition in our Music program leadership. The Music Board did a fantastic job of conducting a search for a new Music Director following the departure of Nathaniel Baker. They not only conducted the search for a new director but found interim musicians to keep our music program going throughout the summer. We welcomed Dan Monte in September, and we look forward to working with him for many years ahead.

2025 was the first year of implementing a fiscal year budget beginning July 1 through June 30. Through the leadership of our treasurer, Jim Cristafulli, we were able to present a balanced budget for fiscal year 2026 and also create a package of funds to address short-term repairs not previously budgeted for.

An Engineering study was commissioned in the early part of the year to identify what repairs or replacements were needed in our aging building over the next ten years. The study revealed that the repairs could add up to a million dollars over the next 10 years. With this important information in hand but also looking to the future and what additional improvements may be necessary to better equip us to fulfill our mission, we are planning for a capital campaign in 2026. The total amount is still to be determined as the cost for improvements is still to be defined.

It has been my honor and pleasure to serve as your Moderator this year. I know that there are great things ahead for our congregation. It is truly a unique place. The Spirit is very much alive and at work at PDCC.

Thank you also to those who helped me lead the Confirmation Class of 2025.

Thank you for the privilege of serving you in the role of Senior Minister. It is through my role here, that I have these unique opportunities for service - whether it be dropping/tossing pumpkins out of the 3rd floor window, or praying for the blessing of the animals (pets), at the Spring Sale. Approval of Minutes

Moderator's Report

Peter referred those in attendance to the Annual report to see the details of the many things accomplished in the past year by boards and committees. He offered these additional comments. The past three years of his term were a time of moving out of COVID and establishing how we can serve our congregation and celebrate our commitment to Christ. He highlighted the implementation of 3 new

services and significant changes in our by-laws as accomplishments. We continue to be an apron-wearing church as demonstrated by our growth in Missions of The Green Team, Tabitha's Closet, and the continued strong support of the Dinner Table.

SPECIAL CONGREGATIONAL MEETING OF PEACE DALE CONGREGATIONAL CHURCH TO APPROVE THE FY2026 BUDGET June 22, 2025

Moderator Joanne Haynes called the meeting to order at 10:52 am.

It was determined that we have a quorum for the meeting.

Opening prayer

Pastor Fred Evenson led us in an opening prayer.

Meeting Purpose and Motions

The purpose of this meeting is to approve the Fiscal 2026 budget and approve the use of existing funds for immediate repairs to the church.

1. Treasurer Jim Crisafulli presented the Fiscal 2026 budget proposal, based on recommendations of the finance committee and the Executive Board. He shared a summary of the budget showing: Income at \$419,695 and Expenses \$419,695, thus a zero based budget.

A Motion was made by Peter Swain to approve the FY 2026 budget as presented.

Second by Marlene Williams

Vote/Passed

2. Jim presented the need for congregational approval to approve using existing funds for immediate repairs to the church. There are \$68,000 in available funds comprised of:
\$48,000 available from the Memorial Fund

\$ 7,000 available from the General Maintenance Fund
\$15,000 available from the Capital Needs Assessment Fund

Three amounts necessary for repairs require congregational approval.

\$14,600 is needed for repairs to the smoke alarm system
\$16,800 is needed for the property management proposal for roof repairs
\$10,000. is needed for repair to gutters and downspouts.

Other repair costs that are under \$10,000 do not require approval but add to the total necessary repair expenses totaling \$67,000.

A Motion was made by John Goldberg to approve spending \$67,000. of existing funds for immediate repairs of the church.

The Christian Education team continues to thrive under the exceptional leadership of Meg Kolodziej, supported faithfully by Tom Kolodziej and Ed Holt. Together with the Christian Education Committee and our dedicated teachers, the team has strengthened both Youth Connect and Youth Group programming while contributing meaningfully to the wider life of the church.

Youth Connect: This year, we were blessed by the creativity and commitment of many church members who brought their talents to the stage—and behind the scenes—to help share our faith in engaging ways. We are grateful for the countless individuals who participate in the Family Services along with our musicians and the Once-a-Month Singers, who enrich our services with energy, joy, and a family-friendly spirit.

Youth Group: Youth Group activities flourished throughout the year. In February, our youth joined Kingston Congregational Church for a Super Bowl gathering at Old Mountain Lanes, offering a fun event for a wide age range. Spring brought our annual Eggstravaganza in April, followed by a lively Pumpkin Palooza in October. BOARD OF DEACONS

The primary responsibility of the Deacons is to "work in collaboration with the Minister for all aspects of the worship, spiritual life and pastoral care of the Church".

Worship service schedules remained the same as the previous year with Traditional worship offered first and fifth Sundays and communion on the first Sundays, Contemporary worship second and third Sundays, and Family worship on the fourth. Attendance continues to increase at all services. For Family services, Meg and her staff provide understandable, warm Biblical message to all, children and adults. We always leave those services with a big smile!

Special Services: Along with weekly services we also celebrated Ash Wednesday, Palm Sunday, Maundy Thursday with communion and Good Friday, a somber and meaningful service led by our 6 Confirmands. Easter was joyfully celebrated at two services! Sunday Advent services were again meaningful with four different families reading seasonal scripture and lighting the candles of Peace, Hope, Joy and Love. A Blue Christmas service was offered this year for those who might be feeling more sadness than joy during the season. It was attended by 26, more than half of whom were not church members.

Confirmands: Speaking of Confirmands, a group met throughout the year with Pastor Fred, Claudia Swain and David Worthen, discussing their faith journey and some theology, and learning about the United Church of Christ history. Our thanks to these adults for getting to know these students and sharing with them. Deacons also met individually with these students before their Confirmation to share faith journeys with them. The yearlong class culminated in Confirmation on June 8, Pentecost. It was a joyous celebration welcoming these dynamic young people into our Church!

Worship Themes and Music: Another responsibility of Deacons is to coordinate worship service themes and music, both traditional and contemporary. The unexpected departure of our Music Director left a large hole to fill, but our prayers were answered by Don Lowell, who agreed to temporarily lead our choirs, provide piano and organ accompaniment, and select all of the music. Don filled this void expertly and graciously, and when our new Director was hired, Don went back to creating the slides that accompany the Contemporary and Family Services, a huge task!

Flowers: The Flower Committee of the Deacons Board is in charge of the interior floral decorations of the Church sanctuary. This includes weekly church service altar flowers, lilies at Easter, and poinsettias/ decorations during Advent. Through the generosity of members of the congregation, Sunday flowers and plants are donated to the Glory of God and in memory of loved ones, in celebration of special people and events, etc. The Flower Committee helps to make this happen. Thank you to the continued dedication of Carol Anne Hayes, Roberta Norman, Claudia Swain, Wendy Sisson and Lynn McCall who are on the Flower Committee Team.

Pastor's Sabbatical: The most time-consuming and rewarding job of Deacons this year was coordination of worship services and pastoral care during Pastor Fred's sabbatical and vacation, June 22-Aug 31. Prior to his leaving Fred suggested names, and contacted qualified ministers to "fill the pulpit" and worked closely with Deacons to provide templates for worship, detailed instructions on how to proceed. Deacons were assigned a specific minister to attend to, contacting them in advance, answering all of their questions, and being there to welcome and assist them. The PDCC congregation thoroughly appreciated the services of Pastor Emeritus Reverend Lawrence Washburn, Reverend Susan Maginn, Reverend John Shaw, Reverend Gino Colderio, Reverend Jean Simpson, Reverend Scott Spencer and Reverend Colin Leitch. We also were treated to a special presentation of PDCC history by our Historian, Stephanie Healy. Administrator MaryLou was the point person to make sure all went smoothly, which it did!

In addition to service coordination MaryLou answered a myriad of daily Church-related questions and facilitated pastoral care during Fred's absence. We can't thank her enough! Prayer Circle and Deacon Enid Watson did and always do a wonderful job of pastoral care. Our dedicated Prayer Warriors meet weekly and confidentially to pray and reach out to those who are in need.

Planning Ahead: With the fall came discussion and decisions about the strategic plan the Deacons will focus on in the year ahead, once again stressing our Extravagant Welcome and working along with many others to create meaningful worship experiences for our apron-wearing Church. Deacons also participated in a call-a-thon, touching base with active and not-so-active members so they know they are appreciated and loved.

Great Stewards will be recognized on February 8, 2026. These folks are hard-working members who participate in a variety of Church tasks and programs, who work tirelessly and joyfully without asking for recognition. It will be a privilege of Deacons to recognize them!

BOARD OF MISSIONS

Below are highlights for the Board of Missions as it continued to serve the greater Peace Dale/Wakefield community this year as well as global missions.

In October, Tabitha's Closet celebrated its second anniversary. The Closet continues to operate each Saturday from 9:30 am – 12:30 pm. Thanks to the donations of clothing from the congregation and others, Tabitha's has been able to provide low cost and some free garments of excellent quality to the community. Many clients have expressed appreciation for PDCC and this mission. Local agencies continue to refer their clients to Tabitha's. We will continue in our attempts to reach all the people in the community who may benefit from Tabitha's. At the end of each quarter the donations made to the closet are redistributed to other missions. This year, the Dinner Table, Pastor's discretionary fund, the Gratitude Tree, CWS kits, St. Peters by the Sea Community Market, Youth Pride RI, and Tri-County Community Action received distributions to help them in their service to the local and distant community. Many thanks to all the volunteers from within and without the congregation that allow the shop to operate and grow. More information can be found in the Tabitha's Closet report.

The Dinner Table continued its great work and in conjunction with St. Vincent de Paul, distributes over 500 meals each week with distribution occurring each Wednesday and Friday. See the Dinner Table report for more information.

The church supported the local Pride parade again by having an exhibitor table/ booth on Main Street with pronoun pins and information on PDCC being open and affirming.

The Pumpkin Patch had another rewarding October. By selling over 5,000 pumpkins, the church was able to raise over \$35,000 from both sales and donations. Those proceeds were divided between the Welcome House and native American growers in New Mexico. This effort was led by Wally Young and Gabby Klensch. The success in this mission is due in a major part to all the volunteers from PDCC, South Kingstown High School, URI, and community members who support us with unloading and sales. Regularly, customers comment about the generosity and importance of Peace Dale Congregational Church in the local community.

The Gratitude Tree mission once again was well supported by the congregation and provided gifts of toys, clothing, art supplies, sports equipment, gift cards and hygiene items to the local area. This year a portion of the proceeds from Tabitha's Closet increased the number of gifts that were able to be donated. These items are distributed to the community through the Jonnycake Center for Hope.

The Green Team was extremely active hosting events on environmental issues and working hard on several other significant initiatives including the Green Amendment and a Green Church designation for our church. The team is growing into an important environmental group in the state. See the separate Green Team report for more information.

Missions of the Month included the Domestic Violence Resource Center, Rhody Outpost (food pantry), UCC L.A. fire relief, Egg A Day (Haiti), Shower to Empower, Camp Lilac and Worcester Congregation

supporting LGBTQ Refugees, Adopt RI, Habitat for Humanity/ a fifth Sunday for Disaster Relief for the Texas Floods, Galilee Mission, Jonnycake Center for Hope, Church World Service, and The Peace Dale Dinner Table. On Christmas Eve we collected for the UCC Christmas Fund supporting retired clergy.

In total, the Missions of the Month received a very generous total of \$62,156.75. The Board of Missions thanks the congregation for their strong support of our work.

For 2026 the committee will continue to look for new opportunities to serve both the local community and the global community as well as planning to keep our core missions running in the future.

BOARD OF MUSIC

Music is an important part of worship here at Peace Dale Church. We are blessed to have an active music program including our:

- Traditional Choir, Dan Monte, Director
- Contemporary Singers Choir, Dan Monte, Director
- Bell Choir, Tricia Halloran, Director
- Ongoing music activities are available on the church website.

In March, our music director, Nathaniel Baker, left the church. Don Lowell took over in an interim role until June.

We created a search committee, advertised nationally, conducted interviews, and auditioned 3 candidates for music director. We hired a new music director, Dan Monte, in July.

We hired two interim accompanists to work through the summer. The board, in conjunction with some members of the choir and other leaders of the church, planned the music for the summer.

In the fall, our Möller pipe organ was tuned/serviced. Our Ritmüller grand piano was tuned/maintained once in both the spring and the fall as was the piano in the Music Room.

The primary goals of the Board of Music for 2025 included:

- Assist and support Dan, our new music director, as he begins his tenure. Guide him and provide feedback as necessary.
 - This included initial meetings to help Dan plan for his September start, monthly meetings with the board chair to discuss successes and needs, and monthly meetings with the Music Board.
- Strategically grow membership of each choir
 - We continued our policy of welcoming any interested people into the choir, adding a couple of new people to each choir.
 - We clarified that new members can decide on their own level of commitment, and encouraged those who can only come on Sunday mornings or who may want to join for a specific time period.
 - We began to give choir testimonials in church as a way of recruiting new folks.
- Continue to clarify roles and responsibilities of the Music Board and the Music Director

We look forward to continuing with these goals, but will also develop a new strategic plan this winter.

Thanks to everyone who helped during this year of change and challenge. A special thanks to Alex Dowgiallo, Alan Santos, and Ellen Hefler who joined the board chair on the Search Committee.

BOARD OF PROPERTY MANAGEMENT

Overview: The Property Management Board takes on the challenge of the maintenance of and improvements to the PDCC facilities comprising 3 main elements (church sanctuary, education wing, parsonage, and associated grounds) constructed at various times over about 150 years. There is important “corporate memory” held and shared among the board members helping to provide continuity of efforts as membership evolves each year. It is important to strive for financially optimal solutions to these challenges which will be economical in the long term and consistent with PDCC philosophies regarding equity and environmental impact (i.e., “green”).

Routine actions performed: Sunday church openings and closings, clock setting and winding, thermostat batteries, f/u with fire extinguisher vendor and date checks, repaired fellowship hall window shade chain, monitor solar array performance (due to favorable weather the array produced 67.5 MWh in 2025, up 3.7 % from 65.1 MWh in 2024).

Special projects in progress: Building and systems assessment: The final Capital Needs Assessment from RIMKUS C3 and BCA based on site surveys in November and December of 2024. Results were shared with the Executive Board (EB), including a 10 year cost projection totaling just under \$1 M over the period. Recommendations for the near term focused on immediate repair of the roof and exterior stone work of the sanctuary and fellowship hall, with full roof replacement shortly thereafter. The Executive Board authorized a follow on contract with BCA to prepare detailed work scope documents suitable for bid packages such that a contemplated capital campaign can be conducted based on firm estimates from potential contractors for these efforts. BCA's output is expected in early 2025 and will be based on on-site surveys and a laser imaging scan of the building envelope.

Future directions, opportunities and challenges: In CY-2026 Property Management will need to address the above capital projects, as well as continuing routine maintenance and the inevitable pop-up problems. Furthermore, construction of a new high school began in late 2025 close by PDCC. In early September a subcontractor of Gilbane, prime contractor for the school efforts, conducted a photographic survey of PDCC and the parsonage to document conditions prior to the start of their work. It will be important to watch for and report any damage that may result from the nearby construction.

BOARD OF STEWARDSHIP

Members of the 2025 Board of Stewardship were John Golberg, Maria Cassaday, Mark Zedella, James Moore, Sylvia Blanda and Jeanine Conrady. We hope that all who are giving so generously to Peace Dale Congregational Church have experienced the transformational joy of giving to show Christ's love here on earth.

The Stewardship Board goals were:

Make the missional work of the church the focus of the stewardship drive. The Stewardship Campaign was conducted in October and November with the theme of "Giving with Gratitude". The

campaign focused on how our giving of time, talent, and treasure allows Peace Dale Congregational Church to minister to our community as well as our congregants. Part of our goal was to foster the concept that without PDCC's structures, both physical and organizational, the good work of our ministries would not be possible. Pastor Fred provided a series of reflections and members of the Board organized representatives from organizations who benefit from our mission work to provide testimonials. Messages in E-light also enhanced the message of our campaign. There was one mailing to congregants, followed by two emails to congregants. Thank you to all who responded with estimates of giving for 2026. There were 71 giving units for a total of \$209,647. This represents 18 fewer pledging units and a reduction of \$23.901 in pledges.

Increasing the number of givers and the amount pledged. The focus of any Stewardship campaign is to increase the number of folks willing to commit financially to PDCC. Therefore, the Board instituted a step-up campaign which showed the spread of those giving and encouraged givers to step up to the next level for 2026. Unfortunately, the number of givers decreased this year from 89 in 2025 to 71 in 2026, a 21% drop. Interestingly, in 2024 there were 73 givers. We believe several factors are at play. Of the 18 not pledging 4 have either died or moved. Of those who have previously pledged, 4 were affected by the government cutbacks. Health issues have plagued several others. On the bright side we have 5 new givers.

Providing alternate ways to give. The various ways to give instituted by prior Stewardship Boards continue. We have on-line giving through Vanco and Pay Pal. Ways to give are highlighted in every worship service through a slide listing those options. The PDCC website also contains updated information about electronic giving. The pew card that provides instructions for giving on-line includes a QR code that takes people directly to PDCC website "Ways to Give". There visitors can use the Vanco account to give as a guest without setting up a permanent account. The pew cards also provide something to put in the offering plate on Sunday morning for those who give electronically to visually show their support.

Lifting up those who make faith commitments. A cake and special hospitality was held on November 17th celebrating the end of our Stewardship drive and thanking those who pledged. The luminaria with the names of those who pledged lighted the way on Christmas Eve. A postcard was sent to those who pledged in 2025 to let them know that the luminaria would include their name and to thank them for their support.

The Stewardship Board also decided to rebrand the Rose Window Society and identify it as Legacy Giving.

FINANCE COMMITTEE AND TREASURER

Finance Committee Report

As of December 31, 2025, PDCC remains on a solid financial footing as members continue to generously support our daily operations. This in turn enables us to complete our faith driven missions for both PDCC members and for the wider community.

Before a brief review of the Revenue and Expense items, a very grateful Thank You is extended to Carol Vetter and Gary Bower both of whom have been instrumental over many years to ensure that our financial statements are correct and our budget is assembled in a highly professional and very thoughtful manner. Both Carol and Gary have recently stepped down from their committee responsibilities, Carol headed the finance committee in recent years and Gary contributed extensively over many years of service by tracking endowment funds and payroll items among other projects. Their expertise has been invaluable as they kept committee members on top of existing financial operations and planning for upcoming issues. Thank you, Carol and Gary, for all your efforts on behalf of PDCC.

Financial Update:

1. During 2024 the church switched from a calendar year financial statement to a June 30 fiscal year. This report briefly comments on our 2025 fiscal year and then on the first six months of fiscal 2026 ended Dec 31 2025.
2. For fiscal year 2025, Net operating income was \$14,000 down from fiscal 2024's net of \$28,000. However, 2024 benefited from a \$25,000 transfer from our general Maintenance reserve to cover property maintenance items.
3. For fiscal 2025, we generated \$415,000 of total revenue up \$10,000 from fiscal 2024. Revenue from members, whether pledged or unpledged, was flat at \$278,000. This represents about 67% of

total revenue. This is no small feat as we have had a declining member base over the last few years. So, thank you to all members for stepping up.

4. Other sources of revenue included rental income – which was up slightly at \$30,000 and \$20,000 – from activities like the Bazaar, Tabitha's Closet and the SCRIP programs. Thanks are due to all the volunteers and leaders who make these programs a success annually.
5. Please note our revenue also includes annual draws from our endowment fund which has continued to grow as the equity in the market has been strong. We transfer about \$60,000 a year from the fund to supplement our income in order to meet our budget. Importantly the Endowment fund investment policy requires the fund to conservatively manage a balanced portfolio of cash in a money market vehicle, bonds and equities. Further the finance committee has established a guideline to draw no more than 6% of the funds principal in any given year.
6. Total expenses are driven largely by salaries and benefits for the Pastor, music director and office manager as well as building costs for heating, electrical and general maintenance. These costs represent about 70% of annual expenses.
7. Moving to our 2026 fiscal year, our six-month statement for July through December reflects net operating income of \$8,700, up \$2,900 from the first six months of fiscal 25.
8. Total member contributions were \$133,000, an \$11,000 increase over the comparative period of fiscal 2025 which reflects an increased commitment to our mission. Revenue from members as a percent of total revenue remained consistent with fiscal 2025.
9. Lastly please note that in fiscal 2025 and during the first six months of 2026 members contributed \$104,000 and \$48,000 respectively to missions run by the church and by other charities. These funds are provided by PDCC members over and above pledges and other donations to the church.

Treasurer's Report

During the first quarter of 2025, I conducted a review of the Church's bookkeeping and accounting procedures and established goals and objectives to strengthen the systems and processes currently in place. I also sought guidance from the United Church of Christ on the role and responsibilities of the Church Treasurer, supported Board Chairs in the preparation of their FY2026 budgets, and initiated a review of the Church's insurance policies in collaboration with the Finance Committee.

Over the spring and summer months, the Church's accounting software was updated to allow for financial reporting on a fiscal-year basis rather than a calendar-year basis. The FY2026 Budget was approved by the Congregation, and, working together with the Finance Committee, a solution was developed to fund the immediate repairs identified by the Property Management team.

In the fall, the Church's longtime Accounting Administrator, Mary Louise McMillan, made the decision to retire from her dedicated volunteer service to Peace Dale Congregational Church. She will be greatly missed, and we extend our sincere gratitude and best wishes to Mary Louise for her many years of faithful devotion to our church. I am grateful that Bob Haynes will be stepping into this role beginning in February. In December, I also worked with United Church Funds to update our authorized users and to establish a new working relationship with our Financial Advisor.

Cash Position, Restricted Funds, and Endowment Account

1. The Consolidated Balance Sheet (provided below, p. 36) offers a snapshot of the Church's financial position as of December 31, 2025, including bank account balances of \$114,256 held at Washington Trust Company and an Endowment Fund balance of \$1,597,284.
2. The Full Balance Sheet provides a year-over-year comparison. While total bank account balances are \$34,561 lower than the prior year, the Endowment Fund balance increased by \$256,930, reflecting a sound investment strategy and favorable economic conditions.
3. Prepaid pledges are \$19,260 higher than the previous year.
4. The final section of the Balance Sheet includes a variety of accounts, including Restricted Funds (from bequests or gifts designated for specific purposes), Unrestricted Funds allocated for special uses (such as property management), and accounts with carryforward balances for Missions, the Bazaar, and other church activities.

THE GREEN TEAM

Peace Dale Congregational Church's Green Team exists to help our church live out our faith by caring for God's creation—through worship, education, advocacy, and practical steps that reduce our environmental impact and deepen our commitment to justice.

In 2025, the Green Team had an active and encouraging year. We strengthened our partnerships, engaged our congregation in new ways, hosted meaningful events, and made important progress on both church-based and statewide initiatives.

A Year of Faith in Action

1) The Rhode Island Green Amendment: Major Momentum in 2025

One of the most significant areas of work this year was introducing and supporting the Rhode Island Green Amendment—a proposed addition to the Rhode Island Constitution that would recognize the right of all people to clean air and water, healthy soil, and a safe climate, and would require the state to protect natural resources fairly for current and future generations.

With Senator Susan Sosnowski's leadership along with the support from Maya van Rossum and "For the Generations" (a national organization working with states across the country), Rhode Island legislation was introduced in both chambers.

Throughout the year, Green Team members helped move this work forward by:

- Providing written and in-person testimony at hearings
- Building relationships with statewide partners such as the Environmental Council of Rhode Island (ECRI), Rhode Island Council of Churches, Climate Action Rhode Island, RI Land Trust Council.
- Hosting or participating in community events to raise awareness
- Encouraging advocacy through E-light updates and church communications

A major milestone came in June, when the Rhode Island Senate voted 32–4 to approve the Green Amendment bill. The bill, however, did not advance in the House. While the General Assembly paused over the summer, we resumed planning in November and have prepared a strategy as the legislature returns in January 2026.

2) PDCC Recognized as a Green Church (Levels 1–3)

In 2025, PDCC continued its progress through the Southern New England Conference UCC (SNEUCC) Green Congregation Program, which sets practical standards for congregations in areas like education, worship, community engagement, and facilities.

We are grateful to share that PDCC has officially been confirmed as a Level 1, Level 2, and Level 3 Green Congregation.

This recognition reflects the ongoing efforts already underway at PDCC—especially in areas such as education, worship integration, and facility improvements. A representative from the SNEUCC presented the awards to PDCC during worship on December 7th.

We are also continuing to work toward Level 4, which involves deeper progress in areas like facilities and operations. (SNEUCC is also introducing an additional higher level, and we'll share more as we learn more.)

3) Creation Care in Worship: Prayer and Testimonies

A key goal in 2025 was to ensure Creation Care is not only something we talk about but something we regularly bring into the life of worship.

This year we:

- Began including a Creation Care Prayer in worship on a regular basis
- Attempted to launch a new practice of short monthly “Creation Care Testimonies” where members share a simple action step they’ve taken to honor creation

The first testimony was shared on April 27 (focused on solar). Considering the lack of response from the congregation, we paused the practice and will consider again in 2026.

Events that Brought People Together

4) Jim Antal Speaker Event (January)

On January 25, PDCC hosted a well-attended event featuring Rev. Jim Antal, author and climate faith leader. More than 80 people attended, representing 10+ churches, plus faith-based and secular organizations.

The event was powerful and motivating, and the recording was shared publicly so others could benefit. We're grateful for everyone who helped make it possible—hospitality, planning, media outreach, and technical support—and for the relationships it strengthened across the community.

5) Earth Day Outreach: URI and PDCC

Earth Day was a highlight of the spring:

- URI Earth Day (April 22): A team of PDCC volunteers supported the event on the Quad. The response was tremendous, and it was especially encouraging to see so many young people engaged. Over 200 Green Amendment petitions were signed at our table.
- PDCC Earth Day (April 27): Our own Earth Day gathering at church brought together education and hands-on engagement, including information about recycling, composting, “No Mow May,” solar, local sustainability initiatives, Tabitha’s Closet (clothing reuse), and more.

These events reflect what we do best as a church: build community, share hope, and invite meaningful action.

6) Climate Future Film Festival (May)

On May 16, PDCC hosted the Climate Future Film Festival, in collaboration with several faith communities. Over 50 people attended. The film was impactful and sparked meaningful reflection and conversation. We are interested in hosting future screenings—likely in a shorter format—when the next release becomes available.

7) Hospitality, Recycling, and Composting Improvements

Throughout the year, we continued to ask a simple question: How can we better align our church practices with the values we proclaim?

We made progress in exploring and implementing next steps, especially around:

- Reducing reliance on disposable plastics
- Transitioning toward compostable products where appropriate
- Improving clarity and use of recycling and compost bins

In October, working closely with Hospitality leadership, PDCC launched a new composting initiative. After researching compostable product options—both through our existing vendor and additional sources—and confirming local compost drop-off with Black Earth Compost at Rose Hill, the church successfully transitioned to compostable hospitality products. This step reflects our commitment to “practice what we preach” by reducing waste and minimizing our impact on landfills.

We also hosted a very helpful Rhode Island Resource Recovery recycling workshop at PDCC in May, with strong participation and great Q&A. A follow-up tour of the Resource Recovery Facility was held in October 2025.

Looking Ahead to 2026

As we head into the next year, our likely priorities include:

- Advance our Advocacy on Environmental policies, including positioning the Green Amendment for future consideration in Rhode Island.
- Completing Level 4 Green Church work
- Continuing to implement sustainable Hospitality practices more fully
- Continuing worship integration (prayers + testimonies) and meaningful public events

Thank You

HISTORIAN’S REPORT

As I stood at the door of the Archive Room for the first time in 2025, I once again read the plaque dedicating the room to former PDCC historian Helen Jones: 2 Peter 1:15: “And I will make every effort so that after my departure, you may be able at any time to recall these things.” Here’s a look at my efforts to follow these instructions.

You may remember that as 2024 drew to a close, I located four journals written by Roland Hazard, with the very first entry dated January 30th, 1857. This entry made formal mention of his desire to begin the organizational process. I immediately began to think of a way that our Church community could continue to remember and praise that cold, winter day when Rowland Hazard II gathered his peers in prayer.

Our Congregation celebrated its very first Foundation Day on January 26th, 2025, and shortly thereafter, the day became permanently enshrined through a proclamation read at our 168th Annual Meeting last year.

Throughout 2025, I've continued to record the hundreds of items in our Archive Room, derived from pictures taken last year.

I organized the Archive Room's Google Drive files, adding newspaper articles and other documents found online. Shelves and file drawers were organized, and our historical collection continued to grow with the arrival of several items from Dr. Reverend Lawrence Washburn, PDCC's pastor of 34 years. The package included newspaper articles, sermons, and notes regarding the Church's efforts to fill the void that existed in affordable housing.

I continue to visit the Archive Room to gather information for my first formal historical presentation entitled "Summer Sanctuary" on August 10th, held during Pastor Fred's sabbatical. This presentation took a deep dive into the events and goings-on of our Church during the summer months, from 1857 to the present.

What's ahead for 2026? I'm excited to share that I'll be meeting with Erica Luke, Executive Director of the South County History Center, providing me with some guidance on the professional preservation of our most important historical documents into a digital format. As we head toward our second Foundation Day celebration, I'm in the midst of researching my next historical presentation, "Winter Sanctuary", scheduled for February 15th.

This is going to be an exciting year for the history of our church, and I can't wait to share the progress with our congregation.

NOMINATING COMMITTEE

The Nominating Committee began working on the 2026 Officer and Board nominations in September of 2025. The committee included Vivian Skipper, Sandi Robinson, Valerie Lowell, Barbara Gilbert and Joanne Haynes, chair. Each committee member was assigned as liaison to different boards and contacted the boards to discuss member participation, potential new members, chair/co-chair positions, projects, goals and any needs or concerns. We determined that there were 11 vacancies for 2026, including officers, board members, and delegates.

We found that there were many eager board members willing to continue on boards on which they were serving. We were also able to recruit new members and active friends to serve in various capacities on the boards. We are blessed to have a number of active members on boards who are very active when they are here, but they also enjoy the warmth of the sun for a few months during winter or in the summer. In the case of those boards where we have a number of snowbirds or beach-lovers, we have increased the membership on the board to assure the boards can continue to operate fully during all the months of the year.

The slate for 2026 is included in the Annual Report. In addition to recruiting board members and officers, chairs and/or co-chairs have been identified for each board. We encourage the boards to operate with

their elected members primarily responsible for planning their program and activities and to use ad hoc (action groups) of volunteers to work on specific tasks or events throughout the year. This will address the often-heard complaint that people want to be “doing”, not attending meetings. We feel this new approach will address this concern and allow more people to participate in a variety of ways. Ad hoc groups for each board have been set up in Breeze to facilitate communication with people in these groups and to easily add more people as they are interested.

The proposed slate of nominees (in Bold Italics) is combined with the existing Board members and has been posted 2 weeks prior to the Annual Meeting on February 8th as required by the By-laws. A huge thank you to everyone who has volunteered their time and talents in service to Peace Dale Congregational Church. A special thanks to the nominating committee members for their dedication to this task.

PEACE DALE DINNER TABLE

On February 19, 2026, the Peace Dale Dinner Table will celebrate its 12th anniversary of operation. Thanks to the phenomenal gifts of time, talent and treasure so generously bestowed by the Peace Dale Congregational Church, the Dinner Table is now serving over 260 take out meals every Wednesday to those in our community dealing with food insecurity. In addition, the Dinner Table also provides a dine-in opportunity each Tuesday for those who would enjoy a meal and the company of others. Finally, the church continues to serve as the home of the “Kitchen of Hope,” which serves 300 take out meals each Friday and further supports our neighbors in need.

Since our start in 2014, food insecurity has grown, not subsided as we had all hoped when this mission began. Every year comes with its own food insecurity crisis. This year, the reduction in our government work force and cut back in food benefits has impacted the community. Our mission to provide food to children and their families, the alone and the hungry continues.

The members of PDCC congregation and the community have been most generous. The church has overwhelmingly supported this mission financially; others supporting the Dinner Table financially include the Rotary Club, the Narragansett Lions, the Elks, the First Baptist Church, the Greater Women’s Federation of South County, the South Kingstown Police Union, the Rainbow Girls and Tabitha’s Closet. This support from the community is both validating and humbling.

We have over 170 volunteers, as well as support from students at the Middlebridge School and the Greater Women’s Federation of South County who cook the second week of every month. Our youngest volunteer is 11, our oldest is 91. We are also a known spot for high school students seeking community service credit hours for Confirmation, National Honor Society and other organizations. Community service hours are also needed for young drivers caught speeding or others that are so ordered by the court. We have met the greatest people! For so many of our Dinner Table volunteers, volunteering not only provides a sense of purpose, but also the knowledge that we in an Ecumenical spirit are working to create Shalom and justice for all as we work to provide nutritious meals to children and their families, the alone and the hungry.

History of Peace Dale Dinner Table

Since February 19, 2014, the Peace Dale Dinner Table has been serving weekly meals every Wednesday to children and their families, the alone and the hungry. Meals are designed to include a protein, starch, vegetable and dessert. Inspirational messages and prayers are sometimes included with meals, as well as other gift items to entertain or comfort our guests.

From 2014 to the time of the COVID shutdown in 2020, meals were served in Fellowship Hall of Peace Dale Church. The Peace Dale Dinner Table was an outgrowth of the Westerly Supper Table which was organized in 2010.

In the beginning, our guests sat at large round tables covered with green checkered tablecloths, set with silverware and dishes. Food was served by an intergenerational group of volunteers, and bussers removed plates and silverware. A wonderful sense of community formed among many of our guests and with our volunteers. The Dinner Table became a regular Wednesday night spot for our 70-90 guests.

From April to August 2020 (during COVID), the Dinner Table ceased operations. We watched what restaurants were doing with take-out meals, and in September re-opened as a reservation-only take-out/home delivery venue. Our numbers grew and grew.

In 2020, the Dinner Table/Peace Dale Church began a collaboration with members of St. Francis of Assisi (now the Kitchen of Hope) who continue to serve meals from PDCC on Fridays. The Dinner Table not only nourishes those for whom we serve and deliver meals but feeds the souls of those who support this mission financially and volunteer.

In 2024, we rebooted our dine-in opportunity and formed the Bistro. On Tuesday evenings, the Bistro serves a hearty, nutritious meal served restaurant style on green checkered tablecloths in Fellowship Hall

PRAYER SHAWL MINISTRY

RAISERIGHT GIFT CARD PROGRAM

The RaiseRight program is a fundraising model where retailers agree to sell gift cards to non-profits at a discount from the face value of a gift card. The buyer gets the full-valued gift card, and the church gets a rebate (anywhere from 1.5% to 20%).

Thanks also to our partnership with the Jonnycake Center of Hope (Kate Brewster and Alicia Monnes) who provided over 10% of our sales this year by using RaiseRight to provide gift cards for their clients. We also partnered with the Missions Board to encourage the congregation to buy gift cards for the Jonnycake Angel Tree from RaiseRight, and with Tabitha's Closet in giving a portion of their earnings to Jonnycake Center of Hope through gift cards. The Pastor's Discretionary Fund also utilizes RaiseRight to provide gift cards for needy families. The RaiseRight program generated over \$6,500 of revenue for the church.

TABITHA'S CLOSET

Tabitha's Closet served the community faithfully in 2025, continuing to advance the three core objectives of its mission since its founding in October 2023.

1. Providing Emergency Clothing Assistance

One of Tabitha's Closet's primary goals is to serve as an emergency clothing resource for individuals and families in urgent need. To raise awareness of this service, we have established relationships with local churches, police departments, first responders, and service agencies, including the Domestic Violence Resource Center, Welcome House, Galilee Mission, the Basic Needs Network, URI Rhody Outpost, and the Jonnycake Center, among others.

Through these partnerships, Tabitha's Closet has provided clothing to families displaced by fire, individuals seeking assistance through the Domestic Violence Resource Center, and many community members experiencing homelessness. We are grateful to be a trusted partner when these critical needs arise.

2. Supporting the Community Through Affordable Clothing and Charitable Giving

Another key objective of Tabitha's Closet is to support the broader community by offering affordable, high-quality clothing while donating net proceeds to local organizations. Over the past two years, Tabitha's Closet has grown significantly—from a single small room to two rooms and a hallway. This summer, the original room was renovated, and our displays and fixtures were upgraded thanks to a generous donation from the owner of Gansett Goods, a gift store that closed in Narragansett. Our sorting area was relocated to the third floor, and we were able to purchase three large cage bins at a deep discount from Jo-Ann Fabrics for off-season clothing storage.

Tabitha's Closet is open Saturday mornings from 9:30 a.m. to 12:30 p.m. Weekly shopper attendance has grown from approximately ten individuals to an average of 30–35, with weekly donations averaging \$300–\$400. We are on track to exceed \$14,000 in net proceeds for 2025. Last spring, we expanded our hours to include one Tuesday evening per month from 4:00–7:00 p.m., coinciding with Bistro Night. Customer traffic during these evening hours has increased significantly.

With the help of Lynne Handanyan and MaryLou, Tabitha's Closet expanded its online presence in 2025 through the creation of a Google profile, consistent posting on Instagram, and promotion on Facebook, Nextdoor, and The Patch. In 2026, we plan to reach out to local newspapers to explore public service announcements.

All net proceeds are distributed through the Missions Board. In the past year, approximately \$12,000 was donated to local charities, including Peace Dale Dinner Table, TriCounty Community Action, ALS, the Pastor's Helping Hand Fund, the Gratitude Tree for the Jonnycake Center, the Rhody Outpost, the Bistro at PDCC, St. Peter's Community Marketplace, and the Domestic Violence Resource Center of South County. Each year, \$1,000–\$2,000 is retained for supplies and the procurement of emergency and promotional items.

3. Environmental Stewardship

Environmental stewardship remains a central component of Tabitha's Closet's mission. Weekly clothing donations continue to be strong in both quality and quantity, with donation bins overflowing most weeks. We also receive regular children's clothing donations from Be Green Consignments.

Based on 2025 sales and an average price of \$2 per item, Tabitha's Closet helped divert over 7500 items from local landfills through sales alone. This figure does not include items given away directly to those in

need or the more than 60 bags of clothing donated each season to Big Brothers Big Sisters. During our “Fill a Bag for \$10” promotion at the Christmas Bazaar, we served 93 customers and moved more than 800 items in just five hours. We also reuse donation bags whenever possible and recycle excess paper, cardboard, and plastic.

Volunteers: The Heart of Tabitha’s Closet

None of this work would be possible without our dedicated volunteers. In 2025, Tabitha’s Closet was supported by 35 committed, capable, and creative individuals who keep operations running smoothly. Our volunteer structure includes a core leadership team, two alternating Tuesday sorting teams, two Friday preparation teams, and pairs of volunteers who staff the shop each Saturday. We also regularly welcome students from Middlebridge, South Kingstown, Prout, Wheeler, and Broad Rock Middle School, providing meaningful community service opportunities. To recruit volunteers and raise awareness, Lynne Handanyan and Suzanne Faucher represented Tabitha’s Closet at the South County Volunteers Applumpkin Fest, the Jonnycake Center, and the URI Civic Engagement Expo, and presented to the Rotary Club. In early 2026, we plan to speak with URI OLLI members to further expand our volunteer base.

Looking Ahead

Tabitha’s Closet has become a place where faith, compassion, and community intersect—a place where individuals feel seen, cared for, and uplifted. This ministry does more than clothe bodies; it restores dignity, strengthens community connections, and reflects God’s love in action. As we enter 2026 amid a challenging economic climate, Tabitha’s Closet will continue to serve as a vital and trusted resource for our community.
